The new SCBA Fill Station and Compressor have been installed thanks to our most recent FEMA Grant.

The firefighters' association has purchased hardware and the related notification service that works through their cell phones called "I Am Responding" providing yet another means of notifying our volunteers of emergency incidents. This system is also interactive and allows each firefighter to signal when they are responding by transmitting this valuable information to a large flat screen monitor in the engine room. This allows for better assembling of crews, early recognition of manpower shortages, etc.

### **ZONING:**

Zoning Inspector Smith gave an updated report on all zoning violations.

Noxious weed letters will be sent out to property owners who are in violation.

### **NEW BUSINESS:**

Steve Bettinger made a motion to increase Chief Tate's salary by \$1000.00. Andrew Bick seconded the motion. Roll call: Eisel-yes, Bettinger-yes, Bick-yes. Motion approved.

### **ROADS:**

Trustee Bick reported Trustees from Providence Township have machines to do the crack seal and would be willing to allow us to use for our road projects.

### **OLD BUSINESS:**

A new bid will be obtained from Slurry Seal for the Washburn Rd. project to include crack fill.

Trustee Bick reported he attended the Village of Berkey Council meeting for discussion on the old fire station repairs and the condition of Washburn Rd. in the Village. The Village will be repairing there portion of Washburn Rd. Further discussion will be held at the next scheduled meeting regarding the old fire station.

Lucas County map of Richfield Township was reviewed and approved.



