ZONING:

Mr. Garlick turned in a site plan an AREIS diagram with a pink slip issued by the Health Department to the Zoning Board for the second story edition to an existing building on Richfield Center Road.

Mr. Smith was asked to check the height of the fence at 11201 Sylvania Avenue and reported it is a six foot fence.

Discussion was held on noxious weeds in the township. Mr. Smith will follow up with calls and letters to all property owners in violation of noxious weeds.

Discussion was held on zoning regulations for signs. In question were the signs located at the carry out on Central Avenue and at the Road House. Mr. Smith will investigate further.

Trustee Nevers reported he has received calls regarding cars being parked on the grass at the Road House. The Prosecutors office was contacted and Mr. Borell stated "Based on the BZA decision, the Road House can only use the existing building, patio and parking lot. He cannot use any other portion of the property for business purposes, including parking."

Mr.Smith will contact Mr. Borell for assistance in issuing the violation letter to the owner of the Road House.
