ZONING:

Continued discussion was held on the blight located at the property on 3302 Washburn Rd. Mr. Curtis, Zoning Board Member, Trustee Bick and Eisel met with the owner to discuss the condition of the property; the property owner was in agreement to work with the Trustees on resolving the blight issue.

Mr. Smith gave an updated report on all zoning violations in the township.

The Trustees along with the Zoning Inspector will follow up on the junk car removal at 10909 W.Central Avenue.

ROADS:

Slurry Seal contacted the Trustees in regards to the bid they were awarded for the Lathrop Rd. project, the bid was figured incorrectly. The Trustees will review all bids submitted for this project to ensure the revised amount will not be over any of the submitted bids.

Slurry Seal: \$6336.00 Asphalt wedge west side of Murd Rd., approximately 525

feet long by 8 feet wide.

S&S Directional Boring: \$9150.00 Install drainage tile under township road.

Slurry Seal: \$2650.00 Crack seal Murd Road.

NEW BUSINESS:

The fiscal officer reported the 2012, 2013 audit is completed. The audit went well with no findings. An amount of \$2557.00 was incorrectly placed in the general fund and was moved to the gas fund

A RESOLUTION REDUCING THE APPRPRIATIONS FOR THE CURRENT YEAR, 2014

WHEREAS, it is necessary to reduce the appropriations to the General Fund due to a recent audit finding funds were misappropriated into the general fund in error.

THEREFORE, BE IT RESOLVED BY THE BOARD OF RICHFIELD TOWNSHIP TRUSTEES OF RICHFIELD TOWNSHIP, LUCAS COUNTY, STATE OF OHIO, THAT:

The appropriations to the General Fund be reduced by \$2557.00.

Steve Bettinger seconded the resolution. Roll call: Eisel-yes, Bick-yes, Bettinger-yes. Resolution adopted.

Trustee Bick attended the TMACOG meeting.

OLD BUSINESS:

Further discussion was held on allowing a township resident to use the town hall for home schooling. Discussion was held on charging winter and spring/fall rates as follows: \$25.00 per day for spring/fall months and \$35.00 per day for winter months. Trustee Bick will contact Prosecutor John Borell for his opinion on having a contract in place and liability issues.

There was discussion on placing new tile or vinyl flooring at the town hall; tile would cost over \$15,000.00. The discussion was tabled until the next meeting.
