# **ADMINISTRATIVE REPORTS:**

The clerk provided copies of the minutes from the August 19th, 2013 meeting, current Cash Summary Report, July Bank Reconciliation and Pending Warrants Report.

# **READING AND APPROVAL OF MINUTES:**

Donald Eisel made a motion to approve the August 19th, 2013 minutes with the following corrections: Trustee Nevers requested to add the statement Ms. Hassen told Mr. Nevers to call the sheriff. John Hassen seconded the motion. Roll call: Hassen –yes, Eisel-yes, Nevers-yes. Motion approved.

#### PRESENTATION OF THE BILLS:

#### FIRE:

August fuel usage was turned in.

Chief Tate reported the occupancy study has been completed at the Road House. The study was completed by Richfield Fire Department along with two additional fire inspectors and the conclusion was as follows: the inside occupancy maximum capacity is 163 and the outside patio maximum capacity is 175. Previously the incorrect capacity rating was 68 inside and 70 outside.

#### **ZONING:**

Mr. Smith reported he has contacted Steve Loeffler to cut the grass at Gary Myers property on Washburn Rd.

Discussion was held on appointing two alternate zoning board members.

Trustee Nevers made a motion to appoint Beth Rosinski and Lee Strain as alternates to the zoning board. Donald Eisel seconded the motion. Roll call: Nevers-yes, Hassen-yes, Eisel-yes. Motion approved.

The August 12<sup>th</sup> zoning minutes were read.

The Fiscal Officer reminded the Trustees of the procedure to follow when there is a record request.

# **OLD BUSINESS:**

No response from Tina Tipping on the town hall rental contract at this time.

An estimate for the siding on the maintenance building was obtained from Siding World for \$3561.22 with an additional cost of \$1147.85 for the lumber.

Estimates will be obtained on the salt shed.

# **ROADS:**

Trustee Eisel spoke with Brian Miller regarding the Murd Road drainage project.

Arthur Nevers made a motion to pursue the Murd Road Drainage project. John Hassen seconded the motion. Roll call: Nevers-yes, Hassen-yes, Eisel-yes. Motion approved.

Discussion was held on applying sealant to the driveway at the maintenance building. An estimate from Jennite Co. was received; further estimates will be obtained.
