Gary Meyer informed Trustee Nevers he would file charges against him for using tax payer dollars for a flight to attend the function in Colorado unless he repaid the money by the next meeting date. Mr. Nevers informed him the Trustees approved the expenditure, it's in our travel policy and Assistant Prosecutor John Borell approved.

Mr. Meyer informed the Trustees he researched the grant for the Kilburn Road paved road project which he states is a participatory grant because the township has to contribute funds towards the project and per the ORC the township has no authority to spend money on a bike path.

He further stated this is against the law and the Trustees should send a certified letter to the administrator of the grant declining the funds. The Trustees advised Mr. Meyer the prosecutor's office had reviewed the grant and the township will save several thousands of dollars by using this grant for the road project.

FIRE:

ZONING:

Zoning Inspector Smith informed the Trustees the Oswald property on Central Avenue would like to put a sign up for their business; Trustee Hassen advised they would have to submit the design/dimensions to the zoning board for approval. There was discussion about the building. It appears that the composition is wood and not steel. Mr. Smith will review the site/building plan with Mr. Ronau.
