# RICHFIELD TOWNSHIP LUCAS COUNTY, OHIO BOARD OF RICHFIELD TOWNSHIP TRUSTEES REGULAR MEETING MINUTES

October 6<sup>th</sup>, 2013

The regular meeting of the Richfield Township Trustees was called to order by Arthur Nevers at 7:00 p.m. at the Maintenance Building, 3951 Washburn Rd., Berkey, Ohio. All present were asked to rise for the Pledge of Allegiance.

## **ADMINISTRATIVE REPORTS:**

The clerk provided copies of the minutes from the September 16th, 2013 meeting, current Cash Summary Report, and Pending Warrants Report.

## **READING AND APPROVAL OF MINUTES:**

Donald Eisel made a motion to approve the September 16th, 2013 minutes with the following correction: Remove statement that Trustee Nevers political sign was placed at the Millers residence. John Hassen seconded the motion. Roll call: Hassen –yes, Eiselyes, Nevers-yes. Motion approved.

## PRESENTATION OF THE BILLS:

The attached listings of warrants (8412-8448) were presented for approval:

John Hassen made a motion to approve payment of the attached listing of invoices and the corresponding pending warrants. Donald Eisel seconded the motion. Roll call: Hassen-yes, Eisel-yes, Nevers-yes. Motion approved.

## **PUBLIC COMMENTS:**

No public comments.

#### FIRE:

Trustee Nevers reported he requested the square footage of the Road House and outdoor patio area from Chief Tate.

Trustee Hassen spoke to a couple residents who were interested in purchasing a lock box system for their homes for the fire department to gain entry in case of an emergency. A lock box is a secure emergency access system for property owners that allow the fire department to gain entry to your property in the event of an emergency. This system allows firefighters immediate entry into homes without forced entry damage or delay. Further discussion will be held when Chief Tate is present.

## **ZONING:**

Zoning Inspector Smith received an estimate of \$400.00 on benches for Wolfinger Cemetery. The benches would be ordered in the spring. Trustee Hassen suggested placing a bench by the flag pole at the cemetery.

Trustee Nevers reported an email was sent to the Trustees from a resident on Bancroft and State Rt. 295 complaining about the noise coming from the band at the Road House. He further stated a resident on Washburn Rd. called and complained about the noise as well.

Trustee Nevers reported he spoke with John Borell at the Lucas County Prosecutors office regarding the parking of cars across the street from the Road House at a recent benefit for Bittersweet Farms. Mr. Nevers stated Mr. Borell advised the Road House can only use the existing building, patio, and parking lot. Anything the owner does beyond that has to go through the Board of Zoning Appeals for approval.

Trustee Hassen and Zoning Board Member Frank Curtis informed Mr. Nevers the cars parked across the street from the Road House were all volunteers for the benefit. Mr. Nevers stated they were still in violation and needed approval from the BZA.

## **NEW BUSINESS:**

The 2013 tax rates and amounts from the Lucas County Auditor were presented to the Trustees for their review.
