FIRE:

Chief Tate attended the Lucas County Fire Chiefs meeting in Waterville on September 26th.

Chief Tate attended the National Fallen Firefighters Memorial Ceremony on October 5th & 6th in Emmitsburg, Maryland.

The radio equipment located downtown that we own and are responsible for that allows Lucas County 911 to page us out for emergencies stopped working and is in need of major repair. This radio is not capable of operating as a "narrow banded" radio and therefore should not be repaired rather should be replaced with a newer technology radio that can operate on narrow band. The FCC has required all public service VHF radios must operate on narrow band starting January 1, 2013. We have already changed all of our other equipment and pagers. The Trustees were in agreement to purchase a new radio.

Arthur Nevers made a motion to purchase a new radio for \$2312.00. John Hassen seconded the motion. Roll call: Eisel-yes, Nevers-yes, Hassen-yes. Motion approved.

September gas usage was turned in.

Chief Tate presented a letter of resignation from Brian Bick from the volunteer fire department.

Donald Eisel made a motion to return to the regular scheduled meeting at 7:32 pm. John Hassen seconded the motion. Roll call: Eisel-yes, Nevers-yes, Hassen-yes. Motion approved.

The regular meeting resumed.

ZONING:

Discussion was held on zoning laws for duplexes in the township.

NEW BUSINESS:

In response to allegations made by Gary Meyer, Trustee Nevers reported he spoke with the Lucas County Prosecutors office and was advised there is nothing illegal regarding the grant for the Kilburn Rd. bike path project or for the reimbursement of Mr. Nevers plane fair to Colorado Springs for the memorial service. He further stated the Trustees made a motion approving his flight expense to the memorial service and it is in our travel policy.

ROADS:

Trustee Eisel contacted the Lucas County Engineers regarding the Murd Road drainage project and they will be presenting a proposal in the near future.
