# RICHFIELD TOWNSHIP LUCAS COUNTY, OHIO BOARD OF RICHFIELD TOWNSHIP TRUSTEES REGULAR MEETING MINUTES

January 5, 2009

The regular meeting of the Richfield Township Trustees was called to order by Arthur Nevers at 7:00 p.m. at the Municipal Building, 3951 Washburn Road, Berkey, Ohio.

**ROLL CALL**: Trustee

Donald Eisel – present Arthur Nevers - present Karen Winn - absent

The Clerk requested nominations for Chairman of the Board of Trustees. Arthur Nevers nominated Donald Eisel. Donald Eisel seconded the motion. There were no further nominations. The Clerk confirmed that the nominations were closed. The vote for Donald Eisel as Chairman resulted as follows: Nevers-yes, Eisel-yes. Donald Eisel was selected to serve as Chairman in 2009.

The Clerk requested nominations for Vice-Chairman of the Board of Trustees. Donald Eisel nominated Karen Winn. Art Nevers seconded the motion. There were no further nominations. The Clerk confirmed that the nominations were closed. The vote for Karen Winn as Vice Chairman resulted as follows: Eisel-yes, Nevers-yes. Karen Winn was selected to serve as Vice-Chairman in 2009.

#### **ADMINISTRATIVE REPORTS:**

The clerk provided copies of the minutes from the December 22<sup>nd</sup>, 2008 meeting, current Cash Summary Report, and Pending Warrants Report.

#### **READING AND APPROVAL OF MINUTES:**

Donald Eisel made a motion to approve the December 22, 2008 minutes as corrected. Arthur Nevers seconded the motion. Roll call: Eisel – yes, Nevers-yes. Motion approved.

#### PRESENTATION OF THE BILLS:

The attached listing of warrants (4-8) was presented for approval.

Donald Eisel made a motion to approve payment of the attached listing of invoices and the corresponding pending warrants. Arthur Nevers seconded the motion. Roll call: Eisel-yes, Nevers-yes. Motion approved.

#### **ZONING:**

Zoning Inspector Hassen reported a meeting will be held at the Jack Mondale residence on Raab Rd. In addition to Mr. Mondale, Mr. Hassen, Mr. Mondale's attorney, Mary Ann Bernath, Lucas County Engineer Brian Miller and the Assistant Lucas County Prosecutor will be in attendance. Mr. Miller will determine the depth of the swale to be located between the Mondale and Bernath properties.

Mr. Hassen researched the ORC on fencing and reported if the property owner at 4242 N. Lathrop Rd. puts up a barbed wire or electric fence he will need approval from the surrounding property owners. He further stated the property owner is in violation as he should have contacted the utility company 48 hours prior to digging the fence post.

Mr. Hassen reported per the ORC a resident who does not reside in the township cannot file a zoning complaint on residents of the township.

Mr. Hassen contacted Lucas County in regards to the copula at 4216 N. Lathrop Rd. and a permit is required through the County for a copula. Lucas County will inspect the property.

There was discussion on the possible commercial trucking business at 13423 Central Ave. The individual who filed a complaint is not a resident of Richfield Township. Trustee Nevers instructed Mr. Hassen to send a violation letter to the property owners. Mr. Hassen did speak with the Lucas County Prosecutors Office and was advised to send the property owner a letter. There was further discussion on whether it is a commercial business as the owner is not hauling anything onto the property. Mr. Hassen will hold off on sending the letter until he speaks with the Prosecutors Office to discuss further.

There was discussion on the property located at 4216 N. Lathrop Rd. A complaint has been voiced to Trustee Nevers regarding the property has a barn with horses; per the Richfield Township Zoning Regulations "Buildings, pens or enclosures used for housing animals shall be a minimum of 50 feet from all property lines and/or any dwelling unit on the site and at least 500 feet from existing dwellings on abutting parcels, including parcels across the street". Trustee Nevers instructed Mr. Hassen to issue a zoning violation letter to the property owner; Mr. Hassen stated he has requested the Lucas County Building office to check into the property and therefore will not send out a letter until hearing back from the County.

Hylant insurance was notified; the township can send Hylant a reimbursement check for the amount that was covered or give Hylant the mannequin. The Trustees were in agreement to give the mannequin to Hylant.
