Discussion was held on purchasing a new thermal imaging camera for the sale price of \$8400.00. Funds remaining in the current FEMA grant (\$4100.00) would be used for the purchase if approved by FEMA; the remaining amount would be divided between the fire association and the township. The Trustees were in favor of purchasing the camera.

Chief Tate informed the Trustees the tires on the brush truck need to be changed; estimates will be obtained.

Soft billing for medical transport has brought in \$14,991.08 thus far in 2013.
