REGULAR MEETING MINUTES**

November 19th, 2012

The regular meeting of the Richfield Township Trustees was called to order by Donald Eisel at 7:00 p.m. at the Maintenance Building, 3951 Washburn Rd., Berkey, Ohio. All present were asked to rise for the Pledge of Allegiance.

ADMINISTRATIVE REPORTS:

The clerk provided copies of the minutes from the November 5th, 2012 meeting, current Cash Summary Report, and Pending Warrants Report.

READING AND APPROVAL OF MINUTES:

Discussion was held on updating the SCBA's (self contained breathing apparatus).

ZONING:

The November 13th, 2012 zoning minutes were read

Zoning Inspector Smith attended a zoning inspector workshop.

Mr. Smith reported the building at 9980 W. Central Ave. does not match the description on the original application and appears to be larger and is wooden stick built, not steel. Mr. Smith will investigate further.

NEW BUSINESS:

The Lucas County Budget Commission has approved the 2013 budget for the Lucas County Health Department. The charges to be deducted from Richfield Township in 2013 will be \$6820.05 (0% increase from 2012).

The approved distribution for the 2013 Local Government Fund will be \$14229.11, decrease of \$4000.00 from 2012.

The Fiscal Officer completed the townships required training for the Ohio Sunshine Law; updates were presented to the Trustee's.

OLD BUSINESS:

Trustee Eisel spoke to Brian Miller (Lucas County Engineer) and he will obtain estimates for the Murd Road drainage project.
