They are asking for an increase in rates of \$1.00 per household due to increase in fuel cost, liability insurance, disposal fee's and tonnage rates. The townships monthly fee would increase by \$500.00 per month. Based on previous bids the yearly rate would remain under the other bidders

Arthur Nevers made a motion to accept the increased rates from ARS and renew the contract for 2 years. Donald Eisel seconded the motion. Roll call: Nevers-yes, Eisel-yes. Motion approved.
