April 19<sup>th</sup>, 2010

The regular meeting of the Richfield Township Trustees was called to order by Arthur Nevers at 7:00 p.m. at the Municipal Building, 3951 Washburn Road, Berkey, Ohio. All present were asked to rise for the Pledge of Allegiance.

## **ADMINISTRATIVE REPORTS:**

The clerk provided copies of the minutes from the April 19th, 2010 meeting, current Cash Summary Report, and Pending Warrants Report.

## **READING AND APPROVAL OF MINUTES:**

Arthur Nevers made a motion to approve the April 5<sup>th</sup>, 2010 minutes with an amendment to change his vote on approving the minutes to a no vote. Donald Eisel seconded the motion. Roll call: Nevers-yes, Hassen –yes, Eisel -yes. Motion approved.

#### PRESENTATION OF THE BILLS:

The attached listings of warrants (5816-5838) were presented for approval:

John Hassen made a motion to approve payment of the attached listing of invoices and the corresponding pending warrants. Donald Eisel seconded the motion. Roll call: Nevers-yes, Hassen-yes, Eisel-yes. Motion approved.

#### **ZONING:**

Zoning Inspector Smith reported there have been no improvements at 10909 Central Avenue.

The property owner at 9980 W. Central Avenue submitted new plans and will need to reapply for a permit.

Discussion was held regarding the properties on Miller Road; Mr. Hadley has drilled 2 wells on one of the properties and did not get any water, he would like to put in a pond.

Mr. Smith informed him the zoning requirements are "three acres or greater for a pond" and the lots are 2 acre lots. Mr. Hadley questioned if he could put in a community pond; Mr. Smith informed him community ponds are not allowed in the township.

#### FIRE:

The Chief gave a report on the firefighters who passed the Fire Fighter 1 class as well as those individuals who passed an EMT intermediate class and Fire Fighter 2 class.

The Volunteer Fire Department Training Grant money was received in the amount of \$5100 00 from the State Fire Marshalls office

Discussion was held on covering the Dispatcher when he is on vacation.

#### **NEW BUSINESS:**

Discussion was held on forming a JEDD (Joint Economic Development District) with the City of Toledo for future water in the township. The Lucas County Prosecutor will be contacted for assistance

#### **OLD BUSINESS:**

Public meeting dates were discussed for the bike trail; the meeting will be held on our regular meeting date June 7th, 2010 at 7:00 p.m. at the Richfield Township Fire Department at 11450 Sylvania Ave., Berkey.

Further discussion was held on the town hall rental as well as the policy for serving alcohol at the township. Becky Swisher (Hylant Insurance) was contacted and advised the township would not be liable if a resident falsifies the contract; she further advised to have residents complete the form in the event there is no charge for rental (funeral dinners, 4-H groups).

#### **ROADS:**

The final plans for the Miller Road Drainage project were received from the Office of the County Engineer.
