# RICHFIELD TOWNSHIP LUCAS COUNTY, OHIO BOARD OF RICHFIELD TOWNSHIP TRUSTEES REGULAR MEETING MINUTES

The regular meeting of the Richfield Township Trustees was called to order by Arthur Nevers at 7:00 p.m. at the Maintenance Building, 3951 Washburn Rd., Berkey, Ohio. All present were asked to rise for the Pledge of Allegiance.

#### **ADMINISTRATIVE REPORTS:**

The Fiscal Officer provided copies of the minutes from the August 18<sup>th</sup> meeting, current Cash Summary Report, and Pending Warrants Report.

## **READING AND APPROVAL OF MINUTES:**

Arthur Nevers made a motion to approve the August 18<sup>th</sup>, 2012 minutes as corrected. John Hassen seconded the motion. Roll call: Hassen –yes, Nevers-yes. Motion approved.

### PRESENTATION OF THE BILLS:

The attached listings of warrants (7654-76) were presented for approval:

John Hassen made a motion to approve payment of the attached listing of invoices and the corresponding pending warrants. Arthur Nevers seconded the motion. Roll call: Hassen-yes, Nevers-yes. Motion approved.

### **PUBLIC COMMENTS:**

A resident pointed out that the rumble strips on Sylvania Avenue can barely be heard as you travel over them. The Trustees will contact Lucas County.

#### FIRE:

Chief Tate turned in fuel usage for July.

The Chief presented an application from Andrea Fletcher to join the volunteer fire department.

Arthur Nevers made a motion to hire Andrea Fletcher as a volunteer fire fighter/EMT contingent upon passing a drug screen, physical and background check with a one year probationary period. John Hassen seconded the motion. Roll call: Nevers-yes, Hassen-yes. Motion approved.

# **ZONING:**

The property owner at 5521 Kilburn Rd. contacted Mr. Smith and reported he would send a check to the township for removing the blight.

Mr. Smith was contacted by the co-owner of Dennis Market on Central Avenue to find out if they can expand; he will attend the next zoning board meeting to discuss with the board.

#### **NEW BUSINESS:**

The Fiscal Officer reported the townships audit was completed with no errors or violations. The State Auditor did find an error from the Lucas County Auditor's office in 2010 \$10,000 in property tax advances were placed on the warrant in error to post to the Bond Retirement fund. \$8000.00 and \$2000.00 should have been placed on the warrant to the Road / Bridge and Fire Fund respectively.

A Fund Balance Adjustment was made to correct the error as follows: \$10,000.00 was deducted from the Bond Retirement Fund and \$8000.00 was placed in the Road / Bridge Fund as well as \$2000.00 in the Fire Fund.

Trustee Nevers requested information regarding the bond refinancing be placed in the minutes: the bond refinancing saved the township \$153,196.00 .00 the old bonds carried an interest rate of 6.00% the interest rate on the new bonds is 4.45% with an yield of 3.35%.

## **OLD BUSINESS:**

There was brief discussion on a noise ordinance; continued discussion will be held at the next Trustee meeting when all are in attendance.
