# RICHFIELD TOWNSHIP LUCAS COUNTY, OHIO BOARD OF RICHFIELD TOWNSHIP TRUSTEES REGULAR MEETING MINUTES

September 6th, 2011

The regular meeting of the Richfield Township Trustees was called to order by John Hassen at 7:00 p.m. at the Maintenance Building, 3951 Washburn Rd., Berkey, Ohio. All present were asked to rise for the Pledge of Allegiance.

## **ADMINISTRATIVE REPORTS:**

The clerk provided copies of the minutes from the August 18<sup>th</sup>, 2011 meeting, current Cash Summary Report, and Pending Warrants Report.

## **READING AND APPROVAL OF MINUTES:**

Donald Eisel made a motion to approve the August 18<sup>th</sup> minutes as presented. John Hassen seconded the motion. Roll call: Hassen – yes, Eisel-yes. Motion approved.

#### MILLER ROAD REPAVEMENT PROJECT BID OPENING

#### **PUBLIC COMMENTS:**

There were questions on the Board of Zoning Appeals pay; the zoning board and board of zoning appeals are paid for meetings on a 6 month basis from January through June and from July through December for all meetings attended.

### FIRE:

August gas usage was turned in.

Chief Tate turned in a resignation letter from Quincy Adams from the volunteer fire department.

Donald Eisel made a motion to accept the resignation from Quincy Adams from the volunteer fire department. John Hassen seconded the motion. Roll call: Hassen-yes, Eisel-yes. Motion approved.

Discussion was held on the sale of the old tanker. Ads will be placed in the Toledo Blade and on the township website with bid opening date on October 5<sup>th</sup> at 7:00 pm at the Richfield Township maintenance building at 3951 Washburn Rd., Berkey, Oh.

Chief Tate advised the Trustees that he appointed Shelbie Briggs as our representative to the Lucas County Mass Casualty Incident (MCI) Team. There is funding available through a grant that Toledo Fire is administering to cover her time and mileage when she attends meetings and training sessions associated with the MCI Team. Chief Tate was requested by Toledo Fire Lt. Cheryl Hill to invoice Toledo Fire in the amount of \$2000.00 to cover her future wages and expenses. Chief Tate provided the Fiscal Officer a copy of the invoice sent to Toledo Fire. Ms. Briggs will keep records of her time and mileage and present them to the Chief every (6) months who in turn will present them to the Trustees. Payment(s) to Shelbie Briggs will be made at an hourly rate of \$12.00/hr plus mileage contingent upon receiving the above funding through Toledo Fire.

#### **ZONING:**

Zoning Inspector Smith will pick up the Swanton Key and distribute to businesses in the Village of Berkey at Country Mark, Jerry's Marathon, Ott's Implement and Keeler's Corners every Monday for residents.

A complaint letter was received regarding blight and an inoperable vehicle with expired tags on the property at 3930 Richfield Center Rd., zoning Inspector Smith contacted the property owner and they have cleaned up the property. Mr. Smith will contact the property owner regarding the vehicle with expired tags.

No response from the certified letter sent to the property owner at 2825 N. Berkey-Southern Rd regarding the vehicle with expired temporary tags.

Violation letter sent to the property owner at 5026 Kilburn Rd. regarding blight has been returned. Trustee Hassen will contact the property owner.

#### **NEW BUSINESS:**

Mr. Farley turned in \$25.00 in town hall rentals for the month of August.

Trustee Hassen reported Lyons LP Gas will lock in propane prices at \$1.84 per gallon; Bextons will mail in rates.

Fiscal Officer reported the Wolfinger Cemetery records have been given to Metamora Public Library for public use.

Ohio Division of Liquor Control sent a letter inquiring if the Trustees had any objections to the renewal of the liquor permit for the Roadhouse. No objections were voiced.
