A resident questioned the status of cleaning up the junk vehicles at the property on Central Avenue. The Trustees will contact John Borell for his opinion on the status of the property being grandfathered in.

A resident on Sylvania Metamora Rd. asked for an extension on demolishing the old house.

CEMETERY:

Discussion was held on increasing the price for cemetery lots at Wolfinger Cemetery; prices were obtained from various cemeteries in Lucas County for a comparison study.

Steve Bettinger made a motion to increase cemetery prices as follows, effective January 1, 2017.

Discussion was held on cleaning the tile, carpet at the fire station. Chief Tate presented estimates as follows: Coit: \$1800.00, Stanley Steamer: \$1100.00.

The Trustees were in agreement to have the tile, carpet cleaned at the fire station for approximately \$1100.00 per Stanley Steamer.

ZONING:

Zoning inspector Smith gave an update on zoning issues.

Discussion held on political sign time limits in the township. The Ohio Attorney General's office advised the township cannot impose durational limits for political signs tied to a specific election as it is unconstitutional.
