Chief Tate announced MercyHealth Mobile Stroke unit will be leaving with a 90 day notice to follow.

Discussion on adding additional coverage at the fire department tentatively from 4pm - 6pm Monday thru Friday. This would add 20 hours per week to fill a void between the stated hours.

Hours will be scheduled as soon as possible from 8 hour shifts to 10 hour shifts.
