ADMINISTRATIVE REPORTS:

Chief Tate provided updates on current grant applications.

Working on a regional grant for new radios.

Chief Tate attended a Lucas County meeting regarding a Countywide EMS System.

Zoning inspector Smith gave an update on zoning issues.

OLD BUSINESS:

NEW BUSINESS:

Discussion was held on the changes to the insurance policy with Hylant Ins. with respect to the value placed on fire department vehicles.

Hylant Insurance updated the Auto Coverage effective 9/1/2017. This modifies the Replacement Cost language under Limits of Coverage. If the replacement cost limit on the policy is equal to or greater than 80% of the actual replacement cost value and the damage is greater than 75% of the replacement cost, then they will replace it with a new auto. However, if the replacement cost limit on the policy is less than 80% of the actual replacement cost, then the modification of the replacement cost language in the policy does not apply.

An updated fire department vehicle list with replacement cost values will be forwarded to Hylant for a cost estimate.

The Secor Metro Park Fire/EMS protection contract was presented to the Trustees for their review.

Discussion held on the ARS trash dumpster located at the fire department. The public is frequently using the dumpster; the intent of the dumpster is for township, fire department use only. Recently someone dumped concrete into the dumpster and ARS refused to take; fire department personal had to get into the dumpster and remove the concrete manually. There has been several other incidents as well involving items such as concrete, building supplies, which ARS will not take. In addition to the above items, there has been incidents of nails laying around the dumpster, which has caused flat tires.

The Trustees discussed the options of placing a fenced in area around the dumpster or removing the dumpster. The Trustees agreed to leave the dumpster in place as well as placing a "Violators Prosecuted No Dumping Sign" by the dumpster.
