The clerk provided copies of the minutes from the April 2, 2018, meeting, current Cash Summary Report, March Bank Reconciliation and Pending Warrants Report.

READING AND APPROVAL OF MINUTES:

Steve Bettinger made a motion to approve the April 2, 2018, minutes as presented. John Hassen seconded the motion. Roll call: Bettinger- yes, Bick –yes, Hassen- yes. Motion approved.

PRESENTATION OF THE BILLS:

PUBLIC COMMENTS:

Mike Pniewski Lucas County Engineer spoke and asked for the Trustees for a resolution of support to the Lucas County commissioners in raising the License plate fee increase of \$5.00 dollars. This would generate approximately 1.8 million dollars that would be used for road and bridge upkeep throughout the county. This would take effect 1/1/2019.

Steve Bettinger made a motion for a resolution in support of the Lucas County commissioners to approve a \$5.00 dollar increase in the license plate fee. Andrew Bick seconded the motion. Roll call: Bettinger-yes, Bick-yes, Hassen-no. Motion approved. See attached Resolution, 041618-01.

There was also conversation with Chief Deputy Engineer Mike Pniewski concerning storm water fees. Lucas County is requesting to assess each property owner \$43.00 per parcel. This money will be used for storm water improvements and help with cleaning ditches. The Trustees will put this on the agenda for the next meeting.

Discussion was held regarding the poor condition of Raab Rd after the county resurfaced. The Trustees along with Chief Deputy Engineer Mike Pniewski were in agreement that Raab Rd. needed to be re-done.

FIRE:

Chief Tate turned in fuel usage for March.

One medic is out of service, working on the air system

ZONING:

Zoning Inspector Smith gave an update on zoning issues.

OLD BUSINESS:

Trustee Hassen spoke with Ohio Gas representative; they are looking into installing natural gas this fall or 2019 in the township.

NEW BUSINESS:

Trustee Bettinger will look into which roads in the township need to be re-striped; the list will be forwarded to Sara at the Lucas County Engineer's office.
