## **READING AND APPROVAL OF MINUTES:**

# **PUBLIC COMMENTS:**

Laurie Manning, Hylant insurance presented and reviewed their proposal for renewal in Ohio Plan Risk Management for the coming year. Premium for 2018 is \$12,870 with a credit of \$1749.00 for having four plus years of service for a total of \$11,211.00.

Hylant notified of the Richfield Township siren not working, Ms. Manning will report the claim. The claim will remain pending until Federal Field Services determines the cause of the siren not working.

#### FIRE:

Further discussion was held on the Richfield emergency siren not working. Federal Field Services has been contacted although they have been unable to drive boom truck into position due to all the rain to check the siren.

Discussion held on whether to repair or eliminate the fire siren with the new technology of pagers and cell phones.

Chief Tate will look into, he reminded everyone that the sirens are used in the event of bad weather alerts, tornados etc. as well. In addition he advised there are times when EMT/Firefighters that live close by may not have cell phone or pagers when working around his/her home and the siren alerts them.

## **ZONING:**

Zoning inspector Smith gave an update on zoning issues.

Lucas County Assistant Prosecuting attorney will send letters to property owners with zoning violations.

## **NEW BUSINESS:**

Insurance bids were reviewed and compared.

Discussion held on cleaning ditches and whose responsibility it is, resident, township or county. Trustee Bettinger will contact the Lucas County Engineers office for clarification.

Trustee Bick and Trustee Bettinger checked the tile on Washburn Rd. after receiving a phone call from a resident. Mr. Bick contacted the county to report the problem; Lucas County cleaned the tile and all is working well now.
