Berkey Village Council member provided information on the consolidated 911 proposal from the county, Matt Heyrman, director of public safety for Lucas County attended the Village Council June meeting. The county is proposing to merge each separate 911 center in the county into one new independent agency that serves everyone. Projected cost for the township is \$13,738 for police & fire dispatch. Currently the township is paying \$5200.00 per year for fire dispatch only; now the County is proposing to charge each jurisdiction for police dispatching based on the percentage of dispatching calls.

The Trustees will invite Matt Heyrman, director of public safety from Lucas County to a meeting in August to discuss further.

The Richfield siren has been temporarily repaired & reprogramed.

Received the donated fire truck from Union Township in Clermont County.

Inspector Ron Smith gave an update on zoning issues.
