RICHFIELD TOWNSHIP LUCAS COUNTY, OHIO BOARD OF RICHFIELD TOWNSHIP TRUSTEES REGULAR MEETING MINUTES

January 2, 2020

The regular meeting of the Richfield Township Trustees was called to order by Steve Bettinger at 7:00 p.m. at the Maintenance Building, 3951 Washburn Rd., Berkey, Ohio. All present were asked to rise for the Pledge of Allegiance.

John Hassen was sworn in as Richfield Township Trustee per the Fiscal Officer.

Andrew Bick – present

The Clerk requested nominations for Chairman of the Board of Trustees. Steve Bettinger nominated John Hassen. Andrew Bick seconded the motion. There were no further nominations. The Clerk confirmed that the nominations were closed. The vote for John Hassen as Chairman resulted as follows: Bick-yes, Bettinger – yes, Hassen-yes. Motion approved. John Hassen was selected to serve as Chairman in 2020.

The Clerk requested nominations for Vice-Chairman of the Board of Trustees. John Hassen nominated Andrew Bick. Steve Bettinger seconded the motion. There were no further nominations. The Clerk confirmed that the nominations were closed. The vote for Andrew Bick as Vice Chairman resulted as follows: Bettinger-yes, Bick – yes, Hassen - yes. Motion approved. Andrew Bick was selected to serve as Vice-Chairman in 2020.

ADMINISTRATIVE REPORTS:

The clerk provided copies of the minutes from the December 16, 2019 meeting, current Cash Summary Report, October & November bank reconciliations, and Pending Warrants Report.

READING AND APPROVAL OF MINUTES:

Steve Bettinger made a motion to approve the December 16, 2019 minutes as presented. Andy Bick seconded the motion. Roll call: Bettinger- yes, Bick –yes, Hassen- yes. Motion approved.

Andrew Bick made a motion to approve payment of the attached listing of invoices and the corresponding pending warrants. Steve Bettinger seconded the motion. Roll call: Hassen-yes, Bick-yes, Bettinger-yes. Motion approved.

PUBLIC COMMENTS:

Dave Turk has concerns with his family property on Central Ave. next door to the Stoll property. He reports more junk cars now added to the property and he believes they are now encroaching on their property. Zoning Inspector Smith will contact Lucas County Prosecutor regarding the above.

Several residents were in attendance voicing concern over the loitering, noise, trash, graffiti, safety, etc. at the Gibbs Road Bridge location and possible remedies. The trustees have contacted Lucas County but have not received a call back at the time of the last meeting. Conversation held on possibly putting up signs, lights, and remote camera's. The Trustees will contact the county to see if a guardrail can be installed along the road to negate the parking along the edge of the road. Trustee Bick reported Gibbs Road Bridge is next on the list for Lucas County to update; Gibbs Rd. Bridge is owned by Lucas County.

FIRE:

Fuel usage for December was turned in.

Chief Klonch presented the Trustees with the second of three annual payments from Richfield Township Firefighters Association to help offset the cost of the power cots recently installed in both rescue squads.

Chief Klonch presented an applications from Joshua Ostrander and Thomas Tray to join the volunteer fire department.

Steve Bettinger made a motion to hire Joshua Ostrander and Thomas Tray to the Richfield Township Fire Department contingent upon passing a drug screen, physical and background check with a one-year probationary period. Andrew Bick seconded the motion. Roll call: Bettingeryes, Bick-yes, Hassen-yes. Motion approved.

Steve Bettinger made a motion to appoint Steve Bettinger as our representative to the Health District, John Hassen as our representative to the Solid Waste Management District and LCIC representative, and Andrew Bick as our TMACOG representative. John Hassen seconded the motion. Roll call: Bick-yes, Bettinger – yes, Hassen-yes. Motion approved

Andrew Bick made a motion to appoint Linda Decker as the Sunshine Law Representative. Steve Bettinger seconded the motion. Roll call: Bick-yes, Bettinger-yes, Hassen-yes. Motion approved.
