Senator Gavarone opened the floor for any questions and left her contact information with the Trustees

Chief Clonch asked for Senator Gavarones support with any legislation that supports volunteer fighters/EMT personal along with the possibility such as tax credits along with dependent benefits. Chief Clonch will email Senator Gavarone the information on current legislation he has been following.

FIRE:

Flu clinic being held at the fire station Friday, October 23, 2020, 9am-12pm. Lucas County Health department will administer the vaccines.

Chief Clonch reported an informational letter along with a fact sheet has been sent to all residents of Richfield Township.

New fire pagers have been ordered and are waiting to be programed. They will be delivered within the next 2 weeks. The fire department has had 2 additional instances that has required personal at the fire department to page volunteers in the case of an emergency. The new pagers will alleviate this issue.

Chief Clonch is looking into a budget that will move future money yearly into accounts for future emergency vehicles such as ambulance and fire trucks.

No news on grants the departments has applied for.

Trustee Bick reported the state of Ohio is reopening covid money to be used for PPE gear. Chief Clonch is aware of this and will be looking into what type of PPE gear this will apply to.

Zoning inspector gave an update on issues and permits.

The last payment just over \$15,000.00 for the two auto lift cots in both rescue vehicles has been paid.
