ZONING:

OLD BUSINESS:

Discussion on 911 fees for dispatching starting in 2022. Fees were based on the average number of 911 calls which include Lucas County Sheriff, Fire & EMS calls. Average calls for Richfield Township is 796 per year.

NEW BUSINESS:

Discussion on resuming townhall cleaning. Trustees agreed to have Deb Johnston resume cleaning to include the following:

- Clean townhall monthly
- Clean bathroom at the townhall after each usage (1 hour)
- Clean maintenance building monthly

The Trustees were in agreement to allow residents to choose their own garbage provider as of January 1, 2022.

Trustee Hassen presented a link for VA benefits, Trustees were in agreement to place on the township website.

Trustee Bick provided information on the Toledo Regional Chamber of Commerce to be held on August 11, 2021 at 12 noon virtually.

ROADS:

Washburn Rd. will have cape seal over the gravel in the near future.

Due to Chip Seal work, Brint Road between Fulton-Lucas Road and Lathrop Road will be closed to through traffic on Thursday, July 8, 2021, for a one (1) day period during working hours. During the closure period a detour will not be provided.

The Lucas County Engineer's Office has contracted The Mannik and Smith Group, Inc. of Maumee, Ohio to obtain pavement cores at the intersection of Kilburn Road and Syl-

vania Avenue in Richfield Township. Lane restrictions with flaggers will be necessary on Friday, July 9, 2021 at the intersection of Kilburn Rd. and Sylvania Ave.
