# RICHFIELD TOWNSHIP LUCAS COUNTY, OHIO BOARD OF RICHFIELD TOWNSHIP TRUSTEES REGULAR MEETING MINUTES

September 19, 2022

The regular meeting of the Richfield Township Trustees was called to order by Steve Bettinger at 7:00 p.m. at the Maintenance Building, 3951 Washburn Rd., Berkey, Ohio. All present were asked to rise for the Pledge of Allegiance.

FIRE:

Toledo Lucas County Health Dept. will hold a flu clinic at the fire department on September 29<sup>th</sup>.

Chief Clonch presented two applications Zach McPherson and Matt Fritsch to join the fire department.

Andrew Lumbrezer made a motion to hire Zach McPherson and Matt Fritsch to the fire department pending a drug screen, background check, physical with a one year probationary period. Steve Bettinger seconded the motion. Roll call: Bettinger-yes, Lumbrezer-yes. Motion approved.

Discussion held on starting a "Cadet Program". The Cadet Program is designed for young adults 16 years of age or older who are interested in learning about a career in the fire service. Cadets would be allowed to attend trainings, events and other activities throughout the year; no active calls. All cadets would need a parental waiver to join.

Steve Bettinger made a motion to approve the "Cadet Program" for young adults 16 years of age or older with a parental waiver. Cadets cannot attend active calls, they can attend trainings, events and other activities. Andrew Lumbrezer seconded the motion. Roll call: Bettinger-yes, Lumbrezer-yes. Motion approved.

#### **OLD BUSINESS:**

Trustee Lumbrezer, Trustee Hassen attended the meeting with an architect to go over plans for new townhall building. Trustee Lumbrezer will contact the grant writer to discuss available grants for a new community building.
