# RICHFIELD TOWNSHIP LUCAS COUNTY, OHIO BOARD OF RICHFIELD TOWNSHIP TRUSTEES REGULAR MEETING MINUTES

December 4, 2023

#### FIRE:

Chief Clonch reported employee Jonathan Hart will be dismissed from his Lieutenant position. There are currently two open Lieutenant positions which will be posted for internal staff. Qualifications include: Fire/EMS certification and one year on the department.

There remains one full-time position on the fire department along with vacancies for several part-time staff. Ads will be placed on Indeed.

The fire department association will be purchasing one utility vehicle as well as pursuing a grant for a skid unit. They are also pursuing getting a trailer at no cost through the state.

#### **ZONING:**

There were two zoning permits issued.

Discussion on the status of the sign located at Christ the Word Church. Zoning Inspector Walters spoke to the church informing them they need to remove the sign asap due to the bright lights that are blinding drivers.

A new contract will be created for the town hall rental to reflect the new rates along with including a disclaimer.

## **ROADS:**

Discussion on purchasing the flashing red stop signs at \$1600.00 per sign. The Trustees were in agreement to purchase two flashing red stop signs to be placed on Washburn Rd/Richfield Center Rd as well as the intersection at Richfield Center Rd/Sylvania Ave.

Road maintenance employee Dan Walters reported the Lucas County Engineers are responsible for all signs at the round abouts.
