ROADS:

At this time the Lucas County Engineers office has not responded back on their findings.

Trustee Bick spoke to the Engineers office regarding the Miller Rd. project for additional details. On the current contract cover letter it states milling and resurfacing. The Engineers offic has stated there will be no milling, the county will place one and one-half to two inches of resurfacing with a 2-course asphalt pavement overlay, minor base repair, drive improvements, adding a 2' stone berm on each side of the road. The road will not be widened.

Current bids for the project will be reviewed at the March 18th, 2024 regular meeting.
